Plus, it increases the chances of the substance abuser getting and staying clean.

You will find that workers who choose union-certified rehab programs will receive the following from the course:

- An evaluation and a treatment plan
- Detox and inpatient rehab services
- A plan that helps the individual remain sober in the short and long-term
- Aftercare services
- Return-to-work certification

On top of these benefits, your union could decide to cover the costs of your treatment via their insurance policy. Even if they only cover a proportion of the expense, it means your exposure is less.

Unions also work in partnership with rehab centers. This allows employees to retain their jobs and employers to retain valued workers who they have invested in over the long-term.

How Does Rehab Work?

Rehab is a safe way for you to deal with potentially dangerous issues. If, for example, you're addicted to alcohol, you need to withdraw from this substance safely without going cold turkey. The same goes for drugs as quitting an addiction at the blink of an eye can often be more harmful.

Rehab centers design medical and non-medical detoxification strategies that give the patent the best chance of success. This includes aftercare work, such as evidence-based therapy and a sober living program.

When Should You Contact Your Union Rep?

These are the telltale signs of substance abuse:

- You're preoccupied with your substances
- You avoid family gatherings and don't socialize
- You're not interested in friends and hobbies due to your addiction
- You experience withdrawal symptoms
- You drug habits leave you broke, and you spend money intended for essentials on drugs


